HISTORY

From 1993 to 2005 UFH acted as a collection system for cooling & freezing appliances according to the Austrian law then in force.

In 2005, the UFH WEEE scheme was founded by the industry- and commerce-driven UFH Privatstiftung, a partner organization of the Association of the Austrian Electrical and Electronics Industries (FEEI), to fulfil the requirements of the European WEEE directive. UFH, approved by the Austrian Ministry of Sustainability and Tourism (BMNT) since August 2005, is divided into two companies:

UFH Elektroaltgeräte Systembetreiber GmbH

collection and recycling system organisation (CRSO) for WEEE and portable batteries

UFH Altlampen Systembetreiber GmbH

collection and recycling system organisation (CRSO) for waste lamps

Since 2008, UFH also acts as a CRSO for portable and industrial batteries.

Since 2014, UFH Holding offers the authorized representative service to fulfil the obligations defined in the WEEE Ordinance on behalf of foreign customers.

UFH further expanded its range of services and began offering disposal solutions for defective PV panel waste starting in January 2016.

In 2018, UFH established a digital B2B marketplace for secondary raw materials, SECONTRADE. The goal is to facilitate trade with valuable raw materials and to promote circular economy.

Since 2022, UFH Holding offers the assumption of the obligations of foreign customers in accordance with the Battery Ordinance for portable batteries as an authorized representative.

LEGAL BACKGROUND

The Austrian Regulations on Waste Prevention, Collection and Treatment of WEEE (WEEE Ordinance) and Batteries (Batteries Ordinance) includes obligations for:

Producers / Importers:

- Online registration at UBA (Umweltbundesamt Environment Agency Austria)
- Regular reporting of EEE-quantities and portable batteries-quantites put on the market in Austria (to UBA)
- Operation of 1 collection point in each district all over Austria (100)
- Concluding an agreement on collecting WEEE and portable batteries with municipalities or otherwise to execute pick up orders by the Clearing House (Elektroaltgeräte Koordinierungsstelle) appointed by the ministry
- Re-use of WEEE
- Collection and recycling of WEEE and portable batteries incl. all reporting responsibilities
- Financial guarantee for collection and recycling of new appliances
- Obligatory system participation for historical waste
- Information for consumers
- Individual marking of each new appliance
- Compliance with restrictions on hazardous substances

Retailers:

• Taking back WEEE from households free of charge on a 1:1 take back basis

Municipalities:

• Taking back WEEE from households free of charge

WEEE CATEGORIES COVERED

UFH covers all WEEE categories of the WEEE Directive.

MEMBERS AND MARKET SHARE

UFH has more than 1,000 members and a market share of approximately 35 %.

FINANCING SYSTEM

Producers and importers are obliged to pay recycling fees on a monthly, quarterly or yearly basis in "EUR per unit", portable batteries "EUR per kg", when they put products on the Austrian market. For producers selling only small quantities, UFH offers a flat-rate option of EUR 160,-. These fees are paid to and managed by the UFH System. The amount is used to fulfil all transferable duties of the producers/importers according to the Austrian WEEE regulations.

COLLECTION SYSTEM / COLLECTION FACILITIES

In Austria there are 6 WEEE collection and treatment categories determined by law:

- Large Appliances
- Cooling Appliances, Refrigerators and Freezers
- Display Screen Equipment
- Small Electrical Appliances
- Lamps
- PV Panels

Since 2008 also waste batteries and accumulators have to be collected in 3 categories:

- Portable Batteries
- Automotive Batteries
- Industrial Batteries

The following **collection facilities** are served through UFH logistic partners:

- More than 2,000 municipal collection facilities
- 100 regional UFH collection points

Retailers are allowed to deliver their own collected WEEE masses to the regional UFH collection points. Upon request, UFH also offers a pick-up service. Consumers can browse through an online database on the UFH-website (www.ufh.at) to find the nearest collection facility and its opening hours.

LOGISTIC SYSTEM / LOGISTIC PARTNERS

UFH has **33 logistic partners**. Some of whom are municipal waste associations, others are private companies. The logistic partners of the system have to provide a regional collection point in each political district of Austria (100 in total) which they are responsible for. They have to collect WEEE from municipal collection facilities and to transport it to treatment partners within the system.

TREATMENT PARTNERS

UFH has 18 treatment partners. They all have to fulfil and document high treatment standards.

RESULTS (COLLECTED AMOUNTS)

In 2022, more than 24,000 tons of WEEE (incl. portable batteries) were collected on behalf of UFH.
