



## International E-Waste Day Contest

### E-waste hunt: emptying my junk drawer

The term “**competition**” applied hereinafter designates the photography competition run by WEEE Forum in the fringe of International E-Waste Day between June and October 2024. The WEEE Forum a.i.s.b.l. (hereinafter referred to as the “we”, “our” and “us”) is an international association representing 51 producer responsibility organisations across the globe. Together with their members are at the forefront of turning the extended producer responsibility principle into an effective electronic waste management policy approach. WEEE Forum headquarters are located at BluePoint conference and business centre, Boulevard Auguste Reyerslaan 80, B-1030 Brussels, Belgium.

- 1) These Terms and Conditions shall be read in conjunction with the other terms and information provided on <https://weee-forum.org/> such as [International E-Waste Day Terms and conditions](#) and WEEE Forum’s [Privacy Policy](#).
- 2) WEEE Forum reserves the right to change the terms of the competition without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the promoter’s control. Any changes to the competition will be notified to entrants as soon as possible by the WEEE Forum.
- 3) Participation conditions are the following:
  - a) The participant should fill in the compulsory fields in the registration form: the name of the author of the photo, e-mail address, country, city, social media link for the posted photo on personal social media accounts, and the answer to the question: on where the e-waste was handed over. The fill in form is available at: <https://weee-forum.org/contest/>
  - b) The participant should upload 1 photo respecting the theme of the contest.
  - c) The social Media post should be sharable and public and have the following tags #ewastehunt #junkdrawer #ewasteday
  - d) The pictures should be in jpeg format.

- e) All submitted photos will be reviewed by the organiser of the contest and the selected ones will be published.
- f) Approved photos which are in accordance with the theme and technical requirements might be published on the social media channels of the WEEE Forum and/or its members (<https://weee-forum.org/members/>).
- g) The organiser will have the right not to publish photos submitted to the contest if they do not match the task description or the theme of the contest, the photo's technical quality does not enable publishing, there is a reasonable doubt about the copyright of the submitted photos, or the same photo has been submitted to the contest more than once.
- h) Only one submission per participant is possible.
- i) The competition is open to residents of all countries above the age of 18 years.
- j) There is no entry fee and no purchase necessary to enter this competition.
- k) Closing date for submitting the applications: 15 October 2024 at 24:00 CET. After this date the no further entries to the competition will be permitted.
- l) No responsibility can be accepted for entries not received for whatever reason.

#### 4) Selection of winners

The submitted photos will be ranked from 1-5 (5 being the maximum) based on 4 criteria:

- creativity,
- respect of the guidance,
- match with the theme,
- technical requirements.

The winners will be selected by a panel composed of WEEE Forum Communication Team.

The winner of the contest will be announced on 22 October 2024 on WEEE Forum's social media and will be contacted by email.

If the winner cannot be contacted or do not claim the prize within 14 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.

#### 5) The prize

The prize is a 7 days Eurail/Interrail pass (depending of the country of residence of the winner) allowing the winner to travel in Europe.

The value of the prize is between 286 eur – 380 eur (or 411 USD).

WEEE Forum will solely provide the train ticket. All the other costs are at the winner's charge (accommodation, European VISA etc).

The WEEE Forum is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this competition.

The prize is as stated, and no cash or other alternatives will be offered. The prize is not transferable. Prize is subject to availability, and we reserve the right to substitute it with another of equivalent value without giving notice.

- 6) By submitting an entry to the Competition (an **Entry**), the participant acknowledges and agrees that:
- a. the Entry, once submitted to the Competition, shall immediately be subject to, and made available for use in accordance with, the Creative Commons Attribution-NonCommercial-ShareAlike Licence 4.0 (the **Licence**), as may be amended or updated by Creative Commons from time to time. In accordance with the terms of the Licence, when using the Entry, WEEE Forum shall include an acknowledgement that the participant is the author of the Entry.
  - b. Once an Entry is submitted to the Competition and made available under the Licence, the Licence cannot be revoked (as per the terms of the Licence). The grant of the Licence is perpetual and irrevocable and will survive termination of these Terms and Conditions for any reason;
  - c. The participant owns the copyright in the Entry submitted and has the full right to copy and transmit the Entry to WEEE Forum for use in the Competition, including for the Entry to be made available in accordance with the Licence;
  - d. The Entry shall not infringe any third party rights or intellectual property rights, including copyright and trade mark rights. In the event of infringement, the participant shall indemnify and hold harmless WEEE Forum for any loss or damage;
  - e. Where an Entry includes image of an individual, the participant gives the permission to the WEEE Forum to use that person's image
  - f. You will not submit an Entry to the Competition that is or WEEE Forum deems to be: unlawful, defamatory, infringing, obscene, sexually explicit, harmful, fraudulent, confidential, libellous, hateful, discriminatory, threatening or contain otherwise illegal material or information or anything which might constitute a criminal or civil offence or promote violence;
  - g. The Entry submitted (and that is subject to the Licence) shall be supplied by the participant in such format as may be requested by WEEE;
  - h. WEEE Forum has the right to use the participant's name and country of residence (as submitted in the Entry) for the sole purpose of identifying the participant as the author of the Entry and/or as a winner of the Competition, in such a way as WEEE Forum in its sole discretion sees fit; and by submitting the Entry, the participant acknowledges that the Entry is an original work and that the participant is the sole author and owner of the Entry (and WEEE Forum and any other person's use of the Entry in accordance with the Licence shall not breach the rights of any third party).

- 7) The participant agrees to the use of his/her name and image in any material, as well as their entry. Any personal data relating to the participant will be used solely in accordance with current Belgian data protection legislation, GDPR rules and WEEE Forum's Privacy Policy.
- 8) Submissions must be made by respondents over the age of 18 (Eighteen). The prize is not open to respondents under 18.
- 9) The WEEE Forum team, their members' representatives, families and relatives are not allowed to take part in the competition.
- 10) The official language of the competition is English.
- 11) If the WEEE Forum has reason to believe an entry is not participant's own work or otherwise breaches these Terms and Conditions, then WEEE Forum shall (in its sole discretion) be entitled not to consider the Entry and may disqualify it.
- 12) By entering this competition, the participant is indicating his/her agreement to be bound by these terms and conditions.
- 13) The competition and these terms and conditions will be governed by Belgian law and any disputes will be subject to the exclusive jurisdiction of the courts of Belgium.
